Selected artwork will be on display in the Aurora Gallery from Feb 1 to Feb 28, 2010. All entries must be available for sale. Commission is 35%. Unsold paintings are to be picked up on Sunday, Feb 28, between 4:00 pm and 6:00 pm.

Send a **self-addressed envelope with sufficient postage** if you would like your photos returned to you. Otherwise, your photos will be kept in the Gallery for your pick up before Feb 28, 2010.

Notification: You will be notified by the Gallery by e-mail on or before **Jan 25, 2010** if your artwork has been selected for exhibition. The artist will then pay the exhibition fee of \$10 per entry to help with the cost of the exhibition. Volunteers are welcome and much appreciated to attend the Gallery.

Delivery of Artwork: Artwork selected for exhibition should be hand delivered to the Aurora Gallery, 2nd Floor, 88 W. Pender Street, Tinsel Town/International Village in Vancouver on **pre-arranged time**. Entrance to underground parking, validated 1 ½ free parking, is at Abbott Street between Pender St. and Keefer Place. If sending artwork by postal mail, please mail to this address as soon as possible:
